



## Fee Schedule - 1<sup>st</sup> September 2020

Thank you for your interest in Communicate without Borders, we look forward to working with you. Please find below an outline of our fees:

### ■ **Fee Rates**

- 90€/hour for assessment and intervention sessions.
- 80€/hour for home programmes, additional meetings, reports, and individual resource development.

### ■ **Sample Fees - you will be informed of exact fees for your child.**

### ■ **Introduction (10 to 15 minutes)**

- We welcome enquiries by email, phone or video call, free of charge.
- You will have the opportunity to chat informally about your child, ask questions about our practice, and discuss what to expect during our sessions.

### ■ **Intake meeting (20 to 30 minutes)**

- A meeting with parents/guardians to discuss your child's history, your concerns, your goals, possible assessment or intervention needs, and any other questions regarding the assessment and therapy process.
- Review client history and past reports.
- Discuss the service agreement, fees and policies.

### ■ **Assessment (45 to 180 minutes)**

- The assessment fee will vary based on individual needs in terms of contact time and report provision, the fee is inclusive of the following:
  - Contact time with children, families or teachers.



- Test materials.
- Scoring and analysing results.
- Provision of a summary report or detailed report with recommendations.
- 20 to 30 minute feedback session.
- Assessments may best be carried out over multiple sessions. The expected assessment time and cost will be provided following the intake meeting.
- Assessment reports will be completed within three weeks of the final assessment session or reception of payment.
- **Assessment fees are due within one the day of the final assessment session or within a day of receiving the payment request.**

#### ■ **Screening (30 minutes)**

- A screening may be offered if you are unsure whether our services are the right step for your child. This can help determine whether a more detailed evaluation is recommended. We will meet with you and your child to conduct informal observation and more formal assessments.
- **Screening fees are due on the day of the session.**

#### ■ **Intervention**

- Sessions range from 30 to 60 minutes.
- Home visits are a minimum of 45 minutes.
- The fee is *inclusive* of:
  - The session contact time;
  - 5 to 10 minutes session wrap up and feedback;
  - Preparation time, home practice tasks and handouts;
  - Treatment notes following each session (optional);
  - Liaising with other professionals your child may be working with;
  - Other administrative costs/emails/phone calls under 15 minutes.
  - 1 IEP/team/review meeting per year (30 to 60 minutes).
- Session duration and cost will be agreed in consultation with families prior to beginning a block of intervention.

#### ■ **Travel Charge**

CWB offers home, school and childcare visits. Travel charges may apply (above 30 minutes).

#### ■ **Telepractice**

Telepractice sessions are billed at the same rate as face to face sessions.
